# A good start in the New Year

The Cariboo winter came with typical unexpected weather conditions. We got it all...extreme minus and plus temperatures and not enough snow to enjoy typical winter recreation. That you have to take it as it comes and look on the bright side of things is something we learned real quickly after arriving in the Cariboo. Whenever things look more miserable than fun, I think of how the pioneers had to deal with it and then it doesn't seem so bad at all.

#### **New CAO**

The CRD board has begun the search for a new CAO (Chief Administrator Officer) through a process led by Interim CAO, Brian Carruthers.

#### High Speed Internet connection projects

Telus has been providing Fiber Optic to the Bridge Lake and Deka Lake area. Many of our properties have now the option to switch to faster Internet. Now the question remains, when will the remainder of our properties be connected? The province is very active with the Connectivity BC program and providing funding for connection projects as performed by Telus, Shaw and ABC Communications. The set target is to provide high speed internet options for all rural communities by 2027. This may be wired or wireless solutions such as Fiber Optic for wired and 5G for wireless. Good news for 300 properties at Sheridan Lake as Telus has announced that Fiber Optic will be brought in there next. The timeframe of installation is not clear yet but I will probe through our Telus contact to get clarification on that.

Many questions with regard to connections for Lone Butte have reached me, so that is also on my list to clarify.

Telus has requested approval for the placement of a tower in the Green Lake area so this will create options for wireless internet connections.

# Charge North

This community Energy Association has been planning and building charging stations for EV (Electrified Vehicle) travel since 2019. The network of 58 stations covers travelling from Kamloops to Prince Rupert and Fort St. John. Currently the route is only covered by class 2 stations where a full charge takes 4-6 hours. The vehicle running time between charging stations allows for a charging time of 2-3 hours. This makes long distance EV travel more suitable for tourists. For locals, the wait is on for the Class 3 fast chargers, which will make long distance EV travel a viable alternative to our diesel or gas engine cars.

#### Cariboo Gold Project

OSISKO Development Corp. has started a project near Wells for an underground mining operation. Currently it is in the Environmental

Assessment Process aiming for approval and start of operations this year. The mine lifetime is estimated at 12 years and will create a total of 314 new jobs in phase 1 and a total of 488 jobs in phase 2. This is a big boost for the employment opportunities in the Cariboo.

Where does our property tax money go?

Is tax money collected from our area also spent in our area or does it disappear into big pots and ultimately spent somewhere in the regional district? This question pops up regularly and is not answered in one sentence. I propose to analyze one line on our property tax notice in this newsletter and gradually work though all of them to try and clarify how each works.

I'll start with a easy one as I have some background on spending this tax money. The Fire Protection taxation will appear as "Interlakes Fire", "Deka Lake Fire" or "Lone Butte Fire" on your Property Tax Notice. It is charged with a rate on improvements and for some departments also with a Parcel Tax. These two collections provide for the total budget of the department. This money comes back to fund all the expenses of the department with some exceptions. The salary of CRD staff involved with the fire protection management of the whole region are paid from this and the 911 dispatch center and radio system maintenance are also charged pro rata. This taxation is an example of tax money spending fully dedicated to a service for our communities in Area L.

Interlakes Volunteer Fire Department

Many of you have approached me expressing your worries with regard to the IVFD and specifically with the suspension of the

Medical First Responder service. The latter is a direct consequence of a lack of volunteers. I have forwarded your concerns and discussed this and other issues with the interim CAO, Brian Carruthers and he, his staff and the Fire Chiefs are addressing the issues.

Deka Lake Community use of Fire Hall

The many concerns which reached me have been discussed intensely with the interim CAO Brian Carruthers. As the situation developed before his time, he is conducting a thorough assessment to get all the facts on the table. He will make sure that the community interests and various options for a solution are considered.

So...I think that is enough to digest in one newsletter. Don't hesitate to contact me on issues in your community. I might not be able to solve everything but certainly will provide a listening ear.
